Background

Lan Diep

Background

Lan is a first-generation Vietnamese refugee living in Naarm (Melbourne), Australia. She works as a change management professional in a national organization focused on mental health and wellbeing. Over the past decade, Lan has actively volunteered with Initiatives of Change Australia (IofCA) Melbourne Branch, participating in programs such as Life Matters (2018), Peace Circle (2019), and mentoring initiatives in Spiritual Ecology (2020). She is currently completing her Governance for Community Directors diploma as a scholarship recipient and has joined IofCA's Nominations and Performance Committee (NPC).

Lan also served as a Regional Advisory Member for the Victorian Multicultural Commission (2019-2022), where she connected grassroots concerns with commissioners to address issues important to multicultural communities across Victoria. She envisions a future where all perspectives are heard and included, emphasizing the importance of seeing the whole and drawing from multiple intelligences, experiences, and knowledge. This approach helps her sense and respond to more nuanced human and technical dynamics, which she believes makes everyone better equipped for the leadership challenges we face.

Statement of Contribution

I bring over twenty years of change and process expertise to IofCA. Inspired by Thich Nhat Hanh's words, "Changing is not just changing the things outside of us," I believe true change involves both external adaptation and internal integration. As a first-generation Vietnamese refugee and immigrant to Australia, my lived experience honors my history of adapting to a new place, culture, language, and people. My volunteer work and role with the Victorian Multicultural Commission reflect my commitment to community engagement and social justice. I am passionate about integrating inner and outer change dimensions to navigate organizational change, particularly for social justice.

I hope to explore strategic change collaboration opportunities and enhance IofCA's impact by adapting partnership strategies to fit the Australian cultural context. My goal is to support initiatives that connect with nature and country, promote personal wellbeing, and foster restorative ways of living and working. I believe in IofCA's vision of building trust across the world's divides and am dedicated to contributing my expertise to further this vision. My strength lies in adapting to new roles, organizational cultures, and innovative ways of working, always learning and evolving. I look forward to serving IofCA, aligned with our shared values and goals.
